Mr. Pat Foley called the meeting to order at 7:00 pm.

Roll call: Mr. Foley – present; Mr. Patrick- present; Mr. Coffman – absent.

The following *staff* were also present: Administrator, Donald Edwards; Fire Chief, Paul Scherer; Road Supervisor, Scott Camery and Fiscal Officer, Darrell Coffman.

**Approval the Minutes of the November 7<sup>th</sup>** meeting was **tabled** due to lack of a quorum of Trustees who were present at that meeting.

**DEPARTMENT REPORTS:**

**ROAD DEPARTMENT:**

Road Department Supervisor, Scott Camery presented as follows:

Regarding the **Road Sign Grant**, ODOT had some personnel losses/changes, consequently our sign order is behind in the process. I have received confirmation that the post and hardware order has been placed and confirmed by the vendor. He has not received any delivery information yet.

**Bushwhacking** is still on the project list.

Currently we have been catching up on **dead tree complaints/requests**.

The rep from Certified Power will be here next week to go through **calibration steps for the White International's salt/liquid delivery equipment**.

While inspecting the roadways yesterday. Mr. Camery observed **unauthorized paint markings on South Cincinnati-Columbus Rd**. The resident painted "Parking" on the road along with lines designating parking spots. This is illegal and has been an ongoing enforcement challenge with different recreational events.

Mr. Camery concluded by stating that the department is at **100% equipment availability**.

**FIRE DEPARTMENT:**

Fire Chief, Paul Scherer reported as follows:

The **replacement portable radio** has been received, programmed and issued back to Lt. Carter.

Parts are on order for **1994 Seagrave**. The work will be scheduled with Vogelpohl once parts arrive.

**Turnout gear** has been ordered with 10 pair of boots & 32 helmets already received.

**ZONING DEPARTMENT:**

The **call for advertisers in the spring edition of *Wayne Township News*** has gone out. She is currently between 60-70% advertiser capacity with 8 ¼ pages full of advertisers and \$3330 in revenue.

Patrick reiterated his call to **reevaluate the township's approach to regulating temporary portable signs.** Mr. Edwards shared information that Ms. Hartsock had gathered from other jurisdictions in Warren County regarding how they enforce temporary portable signs. The discussion will continue at a later date.

**ADMINISTRATOR REPORT:**

Administrator, Donald Edwards reported the following:

Regarding the **Washington Township Fire & EMS Contract**, a discussion was had with Chief Scherer and administration believes we are good with another one year renewal of their contract for 2018 with the same terms and conditions. Mr. Edwards prepared a contract for their Board to execute and return to Wayne Township. Once the contract is returned, he will then present it to the Wayne Township Board of Trustees for approval and signing.

He went on to share that he is working through our last two **claims:** PERSO for the Expedition (Check received and work should be completed next week) and the Radio (check received and new radio has been delivered).

He is getting final **quotes on health insurance** plans and need all insured employees to fill out a Form Fire questionnaire emailed out last week in order to receive exact quote.

He would like to make reservations this week for the **OTA Winter Conference** before they are booked up. Mr. Edwards requested RSVPs for the conference and he would handle registration accordingly.

Mr. Edwards recalled that the **Warren County Hisey Park Dedication of New Observatory** was held on November 9<sup>th</sup>. This event was well attended. This has become a great park with many uses and potential. Great asset for our community.
