Mr. Coffman called the meeting to order at 7:00 pm.

Roll call: Mr. Coffman – present; Mr. Patrick – present; Mr. Foley–present.

The following *staff* were also present: Administrator, Donald Edwards; Fire Chief, Paul Scherer; Roads Department Supervisor, Scott Camery; Zoning Inspector and Asst. to the Administrator, Erin Hartsock; and Fiscal Officer, Darrell Coffman.

The following *residents* were also present: George Cherryholmes, Gary Breeze, Thomas Barklay and Andrew Jacobs.

Mr. Coffman welcomed those in attendance.

Mr. Coffman asked Mr. Breeze to lead those in attendance in the pledge of allegiance to the flag.

Mr. Patrick motioned to **approve the Minutes** of the November 15th regular public meeting. Mr. Foley seconded the motion. Upon call of the roll thereon the vote resulted as follows: Mr. Coffman – yea, Mr. Foley – yea, Patrick – yea.

CITIZEN'S COMMENTS:

Gary Breeze requested that the flags at the Township Building be lowered to half-mast on Pearl Harbor Day.

Andrew Jacobs shared a DP&L's "Gift of Power" program, a program funded through donations designed to pay electric bills for families experiencing financial hardship. Mr. Breeze shared that the Waynesville Food Pantry also has limited funds to assist in-need families with energy bills.

Mr. Jacobs went on to share that DP&L has planned line upgrades in the Sandy Run area as well as Austin Blvd.

DEPARTMENT REPORTS:

ROAD DEPARTMENT:

Road Department Supervisor, Scott Camery reported as follows:

The Trillium Run inspection went well on the 29th of November with only minor items identified to be repaired. Mr. Camery anticipates the road being ready for the Township to accept by the first quarter of 2017.

He shared that he has still not heard from Brewpro, Inc. concerning the return of the cracksealer/melter. He expects to hear from them very soon.

The F-550 has returned from Henderson MFG. We are currently working on installing two-way radios.

All equipment that was sold on Govdeals.com has been paid for and picked up.

Employee evaluations are underway. He hopes to have them completed by the end of the week.

The Department has been busy with final preparations for snow equipment.

While weather permits, they have also reconvened on the Corwin Rd. tree trimming project.

Winfield Estates has been paved (base and intermediate course). Mr. Camery is satisfied with the progress.

The Department was able to do some "berming". Repaired/filled in the worst spots across the township.

Mr. Camery concluded by stating that they are currently at 100% equipment availability

FIRE DEPARTMENT:

Fire Chief, Paul Scherer reported as follows:

For the month of **November**, the Wayne Township Fire Department responded to: **66 EMS calls and 24 Fire calls** for ninety (90) total runs. **Year-end total responses: EMS-901** and **Fire-219** for total count of one-thousand, one-hundred and twenty (1120), which is up by forty-six (46) from 2015. The yearend reports were previously distributed to the Trustees.

The rise in EMS runs was discussed and attributed largely to new procedures of calling Fire Departments in to perform "lift assists" and "lock-outs".

Regarding **equipment**, **cots** and **Stair chairs** have been serviced with minor repairs. And the **2009 PL Squad** had a fuel and differential leak which has been repaired at Lebanon Ford.

Chief Scherer continued by sharing that the Department received \$20,911.60 from the LOEB Grant which will be used to purchase eight (8) sets of turnout gear.

Chief Scherer went on to request approval to purchase another LUCAS 2 Chest Compression System. The purchase would be funded through donations from the State EMS Grant, Quaker Heights Care Community, and Jake Yancey Memorial funds.

Mr. Patrick **motioned to approve the purchase**. Mr. Coffman seconded the motion. The motion carried by unanimous vote.

Chief Scherer stated that a letter had been received from Washington Township.

He went on to share that Deputy Chief Cox has changed positions with Clearcreek Township. His new role brings a standard 5-day work week which precludes Mr. Cox from being available to Wayne Township Monday-Friday day shifts. Additionally, Chief Scherer will be prepared share a report on personnel matters at the December 14th Board meeting.

He also shared that SB 47 has been passed by the Ohio Senate addressing the issue of Workers Comp coverage of certain cancers for Fire Fighters as a workplace injury. He is unsure what financial impact such legislation will have on township budgets, but he views it as a professional victory.

He concluded by sharing that the Wayne Township Holiday Party will be held this Saturday at 6:30 pm at the Methodist Church.

ZONING DEPARTMENT:

Zoning Inspector, Erin Hartsock reported on the following:

Ms. Hartsock went on to share the **timeline for the adoption** phase of the revised zoning code as follows: Open House (Dec. 14); Zoning Commission initiates the amendment process (Jan. 5); RPC makes official recommendation (Jan. 26); Zoning Commission holds first public hearing (Feb. 2); Trustees hold final public hearing (Feb. 21); 30-day voter referendum period after which code will be effective (March 23).

She went on to share that a public hearing will be held at the next Trustees meeting (Dec. 20) for the creation of a **street lighting district** for **Windfield Estates**.

Ms. Hartsock concluded by sharing that the Board of Zoning Appeals would hear a **variance** request regarding deviation from road frontage requirements for 3 parcels near Lytle-Ferry and Township Line Rds. on December 15th.

ADMINISTRATOR REPORT:

Administrator, Donald Edwards reported the following:

Regarding **Fire Station No. 2**, a **contractual agreement for Design Services** for the Wayne Township Fire Station No. 2 project with KZF Design, Inc. was terminated by KZF due to terms, conditions and fee schedule.

Wayne Township is now working with Architects Associated Inc. on a contractual agreement and pricing.

November 28th there was a Pre-Proposal Meeting with short-listed firms for Construction Manager at Risk (Robertson Construction, Thomas & Marker Construction, Schueler Group and Turner Construction, Special Project Division)

Pricing and Technical Proposals are due on the 12th of December with **interviews on Wednesday the** 14th.

Mr. Edwards is also working on getting all documents signed and notarized for the closing for property purchased.

Mr. Edwards has received no response regarding the **Ohio EPA MS4** request for waiver.

As statutorily required in ORC Sections 4928.20(C) and 4929.26(C), we have advertised for two consecutive weeks for two Public Hearings for Wayne Township's **Electric and Natural Gas Aggregation Plan of Operation and Governance.**

The Wayne Township Electric Power and Natural Gas Aggregation Plans of Operation and Governance describe the policies and procedures by which Wayne Township will carry out township electric and natural gas aggregation programs, including those policies and procedures relating to rates and customer service.

The first public meeting was held on Wednesday, November 30 at 1:00 p.m., and the second public meeting was held on Tuesday December 6 at 5:30 p.m. We now are ready to adopt these plans and file an application with the PUCO.

Application for the **2016 MORE grant** from OTARMA has been submitted for emergency lighting for road department truck.

Mr. Edwards concluded by stating **employee evaluations** are being completed along with pay rate recommendations for all employees for 2017.
